The Supplier requirements below apply to all Suppliers and sub-tier Suppliers to Pompano Precision Products providing raw materials, manufactured components and products as well as performing material processing such as, but not limited to: heat treating; chemical processing; surface enhancements; non-destructive and destructive testing; coatings; welding; and nonconventional machining processes for Aerospace products.

Acceptance of Purchase Order from Pompano Precision Products binds the Supplier to the Terms and Conditions listed in the Purchase Order and the requirements listed in this document. The Supplier is not authorized to outsource any portion of the Purchase Order requirements unless specifically authorized by Pompano Precision Products and must flow down these requirements to any sub-tier Suppliers. Note that these requirements correspond with the requirements of Pompano Precision Products customers and with the requirements of AS9100D, Clause 8.4.3.

#### **Requirements:**

- a. The processes, products, and services to be provided, including the identification of relevant technical data (e.g., specifications, drawings, process requirements, work instructions).

  Refer to Pompano Precision Products Inc.'s Purchase Order and/or the Acknowledgement of the Supplier.
- b. The approval of: products and services, methods, processes, and equipment, the release of products and services;

A certificate of conformance (C of C), supplied with the shipment must provide at a minimum: Supplier name, part number, purchase order number, quantity of parts, engineering revision, serial number (if applicable), and title and name of authorized Supplier representative. Material certifications shall show quantitative analysis of each element and physical testing. Traceability for Raw Material is required and shall be retained and provided to Pompano Precision Products with product.

- c. Competence, including any required qualification of persons;
- Supplier will ensure that employees and people working on its behalf are competent and trained in accordance with the requirements of AS9100D.
- d. The Supplier's interactions with Pompano Precision Products;

In addition to the other requirements recorded within this document, Suppliers shall hold all information received from Pompano Precision Products in confidence and no third party request for information will be authorized unless approved, in writing, by Pompano Precision Products Inc.

- **e.** Control and monitoring of Supplier's performance to be applied by Pompano Precision Products; Pompano Precision Products will rate Suppliers based on Quality and On-Time Delivery. Suppliers must maintain a 90% minimum acceptance level. Suppliers that fail to perform in these areas may receive corrective actions and may be considered for probation or removal from Pompano Precision Products's Approved Supplier List.
- f. Verification or validation activities that Pompano Precision Products Inc. or its customer, intends to perform at Supplier's premises;

Pompano Precision Products and its customers reserve the right to perform verification and/or validation activities at the Supplier's premises.

### g. Design and development control;

Design and development control does not apply to Pompano Precision Products suppliers, unless otherwise specified on our PO.

### h. Special requirements, critical items, or key characteristics;

As per the requirements of AS9100D, Supplier is responsible for the validation, and periodic revalidation, of the ability to achieve planned results of the processes for production and service provision, where the resulting output cannot be verified by subsequent monitoring and measurement.

- i. Test, inspection, and verification (including production process verification.
- ii. For calibration Purchase Orders, all gauges and instruments must be calibrated using standards whose accuracies are traceable to the National Institute of Standards and Technology (NIST), the General Conference of Weights and Measures. All provided calibration certifications must specifically state this traceability. Supplier will maintain a quality/inspection system that will ensure all goods and services conform to contract requirements, whether manufactured or processed by Supplier or procured from Sub-Tier Suppliers.

### i. The use of statistical techniques for product acceptance and related instructions for acceptance by Pompano Precision Products;

The Supplier will use a NIST sampling plan with an AQL of 1 or 100% inspection, unless otherwise specified or agreed upon in writing by Pompano Precision Products.

#### j. The need to:

- Implement a quality management system; When specifically requested by Pompano Precision Products in writing, Supplier will maintain a quality system in compliance to recognized Quality Management Systems and/or approved by Pompano Precision Products.
- ii. Use customer-designated or approved external providers, including process sources (e.g., special processes.) When required by Pompano Precision Products or by Pompano Precision Products' customers, Suppliers will use customer-specified sources.
- iii. Notify Pompano Precision Products of nonconforming processes, products, or services and obtain approval for their disposition; Pompano Precision Products will not accept Supplier product that does not meet Purchase Order requirements. Supplier product discovered after shipments by the Supplier to be nonconforming shall be immediately disclosed to Pompano Precision Products, including but not limited to quantity shipped, date shipped, and the extent of the nonconformance. Suppliers that receive notification of Nonconforming product shall take appropriate action to contain the nonconforming condition and prevent it from occurring again. The Supplier will be notified if formal Corrective Action is required to be submitted to Pompano Precision Products Inc.. The response shall be submitted within 2 weeks of issue or a time frame agreed upon between Pompano Precision Products Inc. Company and the Supplier. Errors with paperwork shall be resolved within 24 hours.
- iv. Prevent the use of counterfeit parts (see 8.1.4); To prevent the purchase of counterfeit or suspect / unapproved products and to ensure product identification and traceability (and for other reasons), Supplier will institute controls that include the requirement of Material Certificates of Conformity, and/or other supporting documentation as appropriate. Material and part substitutions are not allowed.

- v. Notify Pompano Precision Products Inc. of changes to processes, products or services, including changes of their external providers or location of manufacture, and obtain Pompano Precision Products approval; Supplier will notify Pompano Precision Products of any change in ownership, management, or location and are subject to re-survey and approval. Supplier will notify Pompano Precision Products of any product or process changes or changes in approval status that affect Pompano Precision Products product and are subject to re-survey and approval.
- vi. Flow down to external providers applicable requirements including customer requirements; Suppliers shall flow-down to Sub-Tier Suppliers the applicable requirements as required by the Purchase order either specifically or by reference.
- vii. Provide test specimens for design approval, inspection/verification, investigation, or auditing. When requested by Pompano Precision Products or its customers, Supplier will provide test specimens for inspection/verification, investigation and/or auditing purposes.
- viii. Retain documented information, including retention periods and disposition requirements; Unless otherwise specified on the Purchase Order, the latest specifications revision in effect at the time the lot of raw material/parts was originally manufactured or processed shall apply. In the event a document has been superseded, the latest revision of the superseding document shall apply. All AS9100D Supplier Flow Down Requirements
- ix. Certifications, test reports, and inspection reports, as well as receiving inspection, in-process inspection, and final inspection shall be retained for a minimum of ten years unless otherwise specified by Pompano Precision Products. Calibration Records must be kept a minimum of 5 years.
- x. Prevent Foreign Object Debris, Supplier is required to establish and maintain a Foreign Object Debris (FOD) prevention program that employs appropriate housekeeping practices to assure timely detection and removal of residue/debris generated, during operations and normal daily tasks.

#### k. The right of access by Pompano Precision Products Inc.,

Pompano Precision Products' customers, and regulatory authorities to the applicable areas of facilities and to applicable documented information, at any level of the supply chain; Pompano Precision Products and Pompano Precision Products' customers reserve the right to perform an on-site inspection of the Supplier's facility or visit the facility. Pompano Precision Products will give reasonable notification to the Supplier prior to the on-site inspection. The on-site inspection may include surveillance of the Supplier's facilities, procedures, production methods, processes, and the Supplier's Quality System. The Supplier shall furnish, at no cost, the necessary data as required by applicable drawings, Purchase Order, specifications, and inspection instructions to facilitate the on-site inspection.

## I. Ensure that people are aware of: their contribution to product or service conformity; their contribution to product safety; the importance of ethical behavior.

- i. Suppliers must be committed to the highest standards of ethics and business conduct. Supplier must comply with law, honor commitments, act in good faith, and be accountable. Supplier must strive to maintain full compliance with all laws and regulations applicable to the operation of the business and customer relations.
- ii. Supplier must not offer, promise, authorize, or provide, directly or indirectly, anything of value (including business gifts or courtesies) with the intent or effect of inducing anyone to engage in unfair business practices.

- iii. Supplier will avoid involvement in activities that may be perceived as a conflict-of-interest.
- iv. Supplier will respect the legitimate proprietary rights and intellectual property rights of customers and Suppliers and take proper care to protect sensitive information, including confidential, proprietary and personal information.

## m. Supplier will support product safety by ensuring robust management of special requirements, critical items and key characteristics.

If there are concerns with respect to product safety, Supplier will communicate them to Pompano Precision Products. If there is a concern at the Suppliers premises with respect to safety during the manufacture of the product, Supplier will notify its own employees of the concern and whenever possible, mitigate the concern. Supplier will ensure that employees and people working on its behalf are aware of:

- Their contribution to product or service conformity
- Their contribution to product safety
- The importance of ethical behavior
